To do so would allow parties to take advantage of the judiciary in such a manner as to deprive the respective States of their constitutional prerogative of sovereignty. Here the policy of the State of Colorado in requiring liability insurance was entered into in order to protect its citizens from the damage or injuries which might be caused by the negligence of others, and to impose penalties as an additional protection. The fund of the State here in question was created by its legislature, not for the benefit of the State, but for the benefit of its own citizens as an element of the protection afforded them by law, and it is just as much the duty of the courts to enforce the provisions of the legislation, under which that fund is created as it is to enforce the various provisions of the Constitution or laws of the United States which all of us are bound to obey. The legislature of Colorado, in creating the Firemen's Fund, expressly provided that it should not be liable in tort, or by any other legal process, for the deficiency of that fund, but that whatever balance might be left after satisfying all claims against the fund shall be remitted to the General Fund of the State, in order that it might be used for any purpose which the legislature might hereafter deem proper; and that it should not be distributed among the various counties and cities of the State, but that the same might be used in payment of the expenses of administering the law. If a necessity should thereafter arise which would render the creation of such a fund desirable, and the legislature should so provide by amendment of the Constitution and laws of the State, then it would be its duty to do so. The same argument is advanced with reference to the three-cent stamp fund, namely that, if the fund now in question is the only fund created by the acts of the legislature, then the tax on the use of that fund should be of such a character as will operate as a mandate upon the legislature to use those taxes for the purposes of the Firemen's Fund, as is evidenced by the provision in the Constitution as to the three-cent stamp. While it is true that the three-cent stamp fund is created by special and enumerated provisions of the Constitution, which are
